

101st Running of the Indy 500 - Sweepstakes Promotion Rules

1. Eligibility: Sweepstakes Promotion (“101st Running of the Indy 500”) is open to those who purchase a minimum of (1) one race at K1 Speed - 9998 E 121st St, Fishers, IN 46037 during the Sweepstakes Promotion Period (May 1 - May 21, 2017).
